

Shannon C. Miller, M.D., DFASAM, DLFAPA Board Certified in Addiction Medicine Board Certified in Psychiatry Dr. Miller is Board Certified in Psychiatry and Board Certified in Addiction Medicine, and has maintained re-certification for over 25 years. He has additional certifications in Buprenorphine and Tobacco Treatment; and was among the very first physicians trained and certified to prescribe Buprenorphine in the U.S. He is a native of Ohio and was awarded full scholarships from the United States Air Force (USAF) for undergraduate education (first in physics, then in pre-medicine), was graduated valedictorian, and then earned a full USAF scholarship for medical school. After medical school, he then completed residency in psychiatry where he ranked in the top 1-2% among U.S. psychiatry residents on standardized testing. Selected from residency by the Psychiatry Consultant to the USAF Surgeon General to serve at the high visibility Presidential base of Andrews USAF Base in Washington, DC, he treated a variety of high-profile military and federal officials, as well as rare conditions. Here he served in the Tri-Service Addiction Recovery Center – the worldwide tertiary referral center for the diagnosis and treatment of addiction-related disorders within the Department of Defense (DoD). In short time, he was promoted to Chief Administrative and Clinical Officer. As Chief, he was awarded the DoD Meritorious Service Medal for vastly modernizing service design, reducing costs, and translating several cutting-edge research findings into clinical practice; and earning one of few USAF Best Practice Awards.

Hand-picked by the DoD as the *Lead Editor/Author* for a first-ever VA-DoD clinical practice guideline for the management of substance use disorders, Dr. Miller has been active in a wide range of topics relating to addictions and has authored roughly 90 medical publications, including his own peer-reviewed medical research. For twenty years, he has served as *Co-Editor*, then *Senior Editor* for 4 consecutive editions of <u>Principles of Addiction Medicine</u>, the flagship medical reference textbook for the American Society of Addiction Medicine (ASAM). Dr. Miller has been selected as a "Distinguished Fellow" of both the American Psychiatric Association and ASAM, and has *Co-Chaired* ASAM national medical conferences. He has co-authored a clinical practice guideline for the management of opioid therapy in chronic pain. Dr. Miller co-founded ASAM's peer-reviewed medical journal, Journal of Addiction Medicine, and served as its *Co-Editor* for a decade.

Throughout his career, Dr. Miller has maintained an active clinical practice. He has over 30 years direct clinical experience specializing in addictions, including government and private practice, both inpatient and outpatient withdrawal management, rehabilitation, cooccurring psychiatric disorders, corrections, methadone, buprenorphine, chronic pain, drug testing, impaired providers, gambling, and a wide array of addiction-related disorders. He has earned awards in teaching, leadership, research, and clinical excellence; including the Humanism in Medicine Award (American Medical Association). He has served his country as a USAF officer, both in active duty and the reserves, through to retirement as a Lieutenant Colonel in the USAF Research Laboratory. Dr. Miller most recently retired from the Department of Veterans Affairs while serving in a community-based outpatient clinic providing services for psychiatric and addictionrelated disorders in collaboration with primary care providers, while also performing IRBapproved clinical research, as well as providing policy and clinical consultation support to a medical center-housed addiction service line. He serves as Clinical Professor in both the Department of Psychiatry and Department of Population and Public Health Sciences at Wright State University Boonshoft School of Medicine. His contributions to ASAM, including co-creating its medical journal, leading its reference textbook, and pioneering its efforts against stigmatizing language have been memorialized in ASAM's history book: Treat Addiction, Save Lives.
